**ANNUAL REVIEW 2017-18** 

Another year has passed and time to reflect on another year of challenges and opportunities. It has been a year when we have said farewell to some long standing colleagues who have left us for pastures new or retirement and our AGM will be a chance to offer our thanks and best wishes.

Our current strategy ends this year and we are working to refresh what we do and how we do it. The safety and wellbeing of people remain central to everything, whether that is the young people in school or our older residents in Grange. We will use our development time as a Board to look for new ways to deliver services, to reach out to new beneficiaries and to challenge ourselves to think beyond the "norm" and continue to innovate. A small but excellent example of our innovation is the development of a VI rugby ball funded by a grant from The Albert Gubay Charitable Foundation.

We have strengthened our Board and Governors this year and warmly welcome those who bring new and different skills to strengthen our governance but there is more to do. The Charity Governance Code highlights the need to ensure a diverse board: "Diversity, in the widest sense, is essential for boards to stay informed and responsive and to navigate the fast-paced and complex changes facing the voluntary sector. Boards whose trustees have different backgrounds and experience are more likely to encourage debate and to make better decisions.

The term 'diversity' includes the nine protected characteristics of the Equality Act 2010 as well as different backgrounds, life experiences, career paths and diversity of thought. Boards should try to recruit people who think in different ways, as well as those who have different backgrounds".

We are committed to developing teachers of the future and we have been delighted to welcome the first cohort of students to study the Mandatory Qualification for Teachers of Visually Impaired (MQTVI) in our new Professional Development Centre: these are teachers and custodians of our skills and knowledge in years to come. Externally we have been recognised as excellent by OFSTED and received equally positive feedback from the Care Quality Commission for our services for older people.

What is next? Nothing stands still, nor should it. We have to meet the challenges of a changing commissioning environment and increasing demands on some of our services. I'm confident it will be an exciting and productive year and with the support of a fantastic team of staff and trustees, we will meet the challenges head on. Our finances are secure thanks to Sue Robertson our Finance Director and her team and this affords us the opportunity to take some risks and try new things.

This year we are able to report a small increase in the Charity's funds of just over £223 thousand pounds. We hear much in the media these days of the underfunding of social services and the struggle of local authorities to manage their budgets. Some of this is reflected in the significant difference between the income we receive for the services we provide and the cost of provision of those services. There is a shortfall for our charity in that funding of over half a million pounds. As a charity, we have other sources of income, such as legacies and donations and rent from others who use our premises. It is sobering to recognise that we would be reporting only a small surplus if it had not been for the legacies we received last year.

That is a useful lead to a reminder that our charity is about people and not just those who benefit from the services we provide. We have a solid core of faithful and committed people who provide those services day-to-day and who, by so doing, leave their own legacy of happy and content residents, pupils formed for their future life and people losing their sight who are better able to manage the effect that disability has on their lives. Our annual review is about celebrating success and achievement, all of which is built on the legacy of those who have supported our charity, not just in the last year, but in many different ways over 177 years. We have much for which to say 'thank you'.

Charitable giving means giving without expecting anything in return. Yet, it so often happens that charity brings its own rewards, not always discernible in today's materialistically-focussed world. # ST VINCENT'S SCHOOL

Our 'common good' curriculum remains at the centre of school as the medium through which to seek and secure better 'outcomes' for our pupils . By outcomes we mean opportunities, flight paths to employment meaningful engagement and friendship groups. We have been building an 'enriched' curriculum to support the National Curriculum enabling us to create innovative individualised opportunities. The story of the enriched curriculum is shared as it develops and happens on Twitter @stvincentsL12 and @sightboxuk We have been building our curriculum to demonstrate INTENT, IMPLEMENTATION and IMPACT.

- We remain an 'OUTSTANDING' school with another Ofsted outstanding rating for our residential provision and in the Archdiocese RE inspection
- We have connected our school curriculum with the 'United Nations Sustainable Development Goals' in seeking equality of education and equality of provision
- We have maintained peer review publications and conference keynotes
  to ensure our work and our services are brought to the attention
  of funders and policy makers locally, nationally and internationally.
  This is best evidenced by Dr Patterson being invited onto Mayor
  Andersons 'Task Force for Indonesia' which facilitated a visit
  from Surabaya by Mayor Risma who wishes to send 10 pupils a year to
  St. Vincent's for targeted educational input. This is under negotiation.

- Sightbox continues to develop as part of our curriculum and as a
  marketing tool for school (IMPLEMENTATION). We are attracting pupils
  to school using this as the medium. Discussions have taken place and we
  are moving forwards surrounding the generation of St. Vincent's as an
  educational 'hub' for Visually Impaired.
- We have pupils securing qualifications and alternative qualifications which includes the Duke of Edinburgh Award. Pupils enrichment work has secured awards and been published through the National Commemorations of the Great War from Never Such Innocence the Lions and Rotary (IMPACT)

Moving forwards our enrichment ceramic work as a means to celebrate our pupil creativity and also market school has won the Never Such Innocence competition meaning our pupils have been invited to celebrate their work in Berlin and Buckingham Palace. Simultaneously, their work will be hung in St. Georges Hall and will be presented to the Houses of Parliament on 29th October where Dr Patterson has been asked to address the House. We are working hard to bring 10 Indonesian pupils to school in June and to create a musical performance booked for The Philharmonic Hall 20th July 2019.

St Vincent's School remains a Directly Licensed Centre for the largest youth award in the World – The Duke of Edinburgh's Award. Starting our fifth year of delivering the award, the DofE encourages young people to take on a challenge





and find their true potential. As part of the enrichment afternoon pupils' have been working on a ceramic panel for parliament - raising awareness of sight loss

It is envisaged that through this innovative course, St. Vincent's will ensure that all those training to teach blind and partially sighted children will aim high and push boundaries to allow all those in their care to become independent young adults who will be prepared for the transition into the world of work and beyond.

## SIGHT LOSS LEARNING HUB

#### Sight Loss Learning Hub

This is the name we chose in the rebranding of our Centre after consultation with our service users.

"It says what it does on the tin" was a comment we heard repeatedly.

Listening to our service users is an important part of what we do at our Hub, we realise that everyone has a part to play in the development of the service we

provide, from service users, volunteers and staff. Our Entry / Exit Questionnaire which we started in 2010 - forms the basis to our Service User Outcome Report which highlights the outcomes achieved and the distance travelled by people living with sight loss during their time at our Sight Loss Learning Hub.



Partnership working has enabled us to reach out as far as Japan with teachers from the Blind School of Saitama visiting us earlier this year.

A massive success for 2018 is Michael, currently a service user who we helped get statemented with Autism Spectrum Disorder (ASD) and re-housed in nearby sheltered accommodation. Michael also continues to receive help from Liverpool City Council Aspergers Team. Everyone at the Hub including his peers have been instrumental in turning his life around beyond recognition, in his own words..."I am now living at Morley Court, in my flat, by myself but with people all around me. I now feel I have my own life again. I still attend Christopher Grange and really enjoy it. At this moment, I can safely say I'm having the best days of my life" Michael, August 2018



Looking forward to 2019, we must all work together to create a world where barriers to opportunities, further education, employment and resources no longer exist.

We are at a crossroads and there is an opportunity, if we are ready to seize it, instead of accepting the status quo – and leaving behind the individuals who are visually impaired to lack of choice and opportunity.
